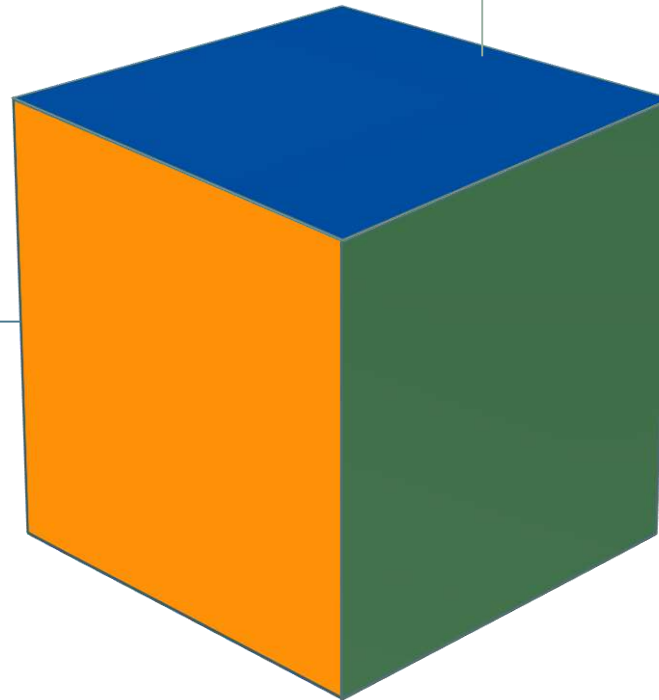

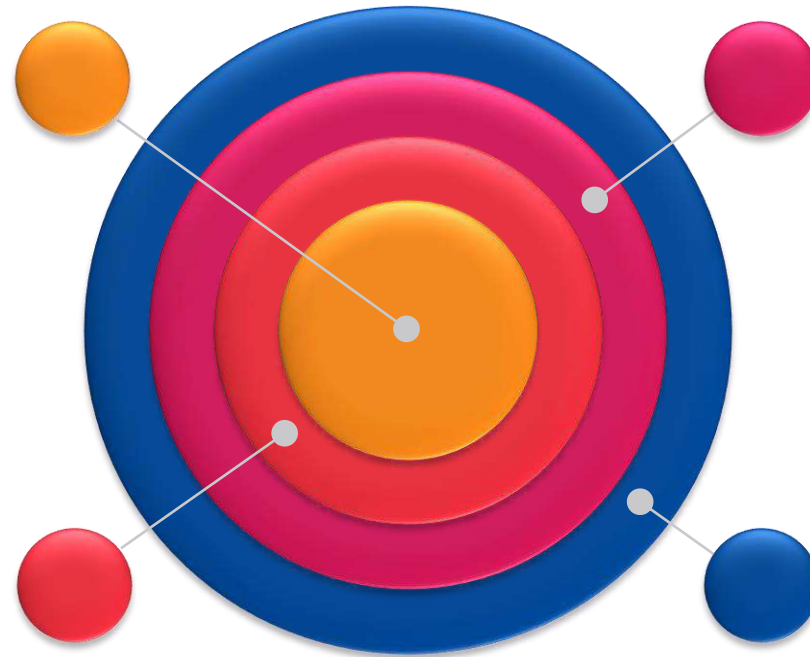
Key Components of IT Asset Management Services
